MIDOR A Complete Integrated Entity

MIDOR is one of the most advanced refineries in Africa and the Mediterranean; reaching a standard of 15.6 Complexity index after Expansion, according to Nelson complexity Index.

The refinery designed capacity after Expansion is 7.8 million tons/year ; equivalent to 160,000 BPSD.

It implements deep conversion units that maximize the production of white products with a refining capacity of 5.0 million barrels per month.

MIDOR is equipped to produce Euro5 products as the Expansion project reached Provisional Acceptance and started operation with a total investment cost of 2.7 billion USD.

MIDOR was established on 21/7/1994 under the Ministerial Decree No. 323 of 1994.

This policy shall determine external context(technological, economic...etc.) and internal context (values,culture...etc.) that are relevant to Midor's purpose and strategic direction.

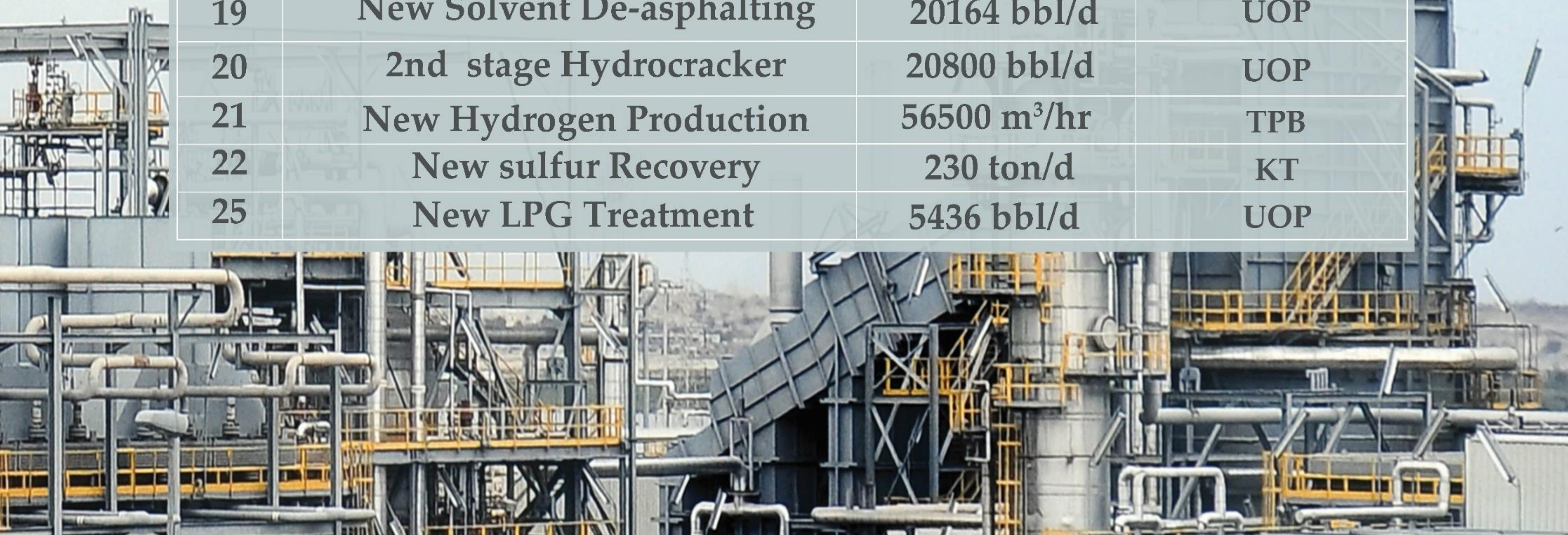
Focus on products quality aiming to meet the customers' requirements and ensure timely products delivery.

The quality policy shall be periodically reviewed to confirm its adequacy and effectiveness.



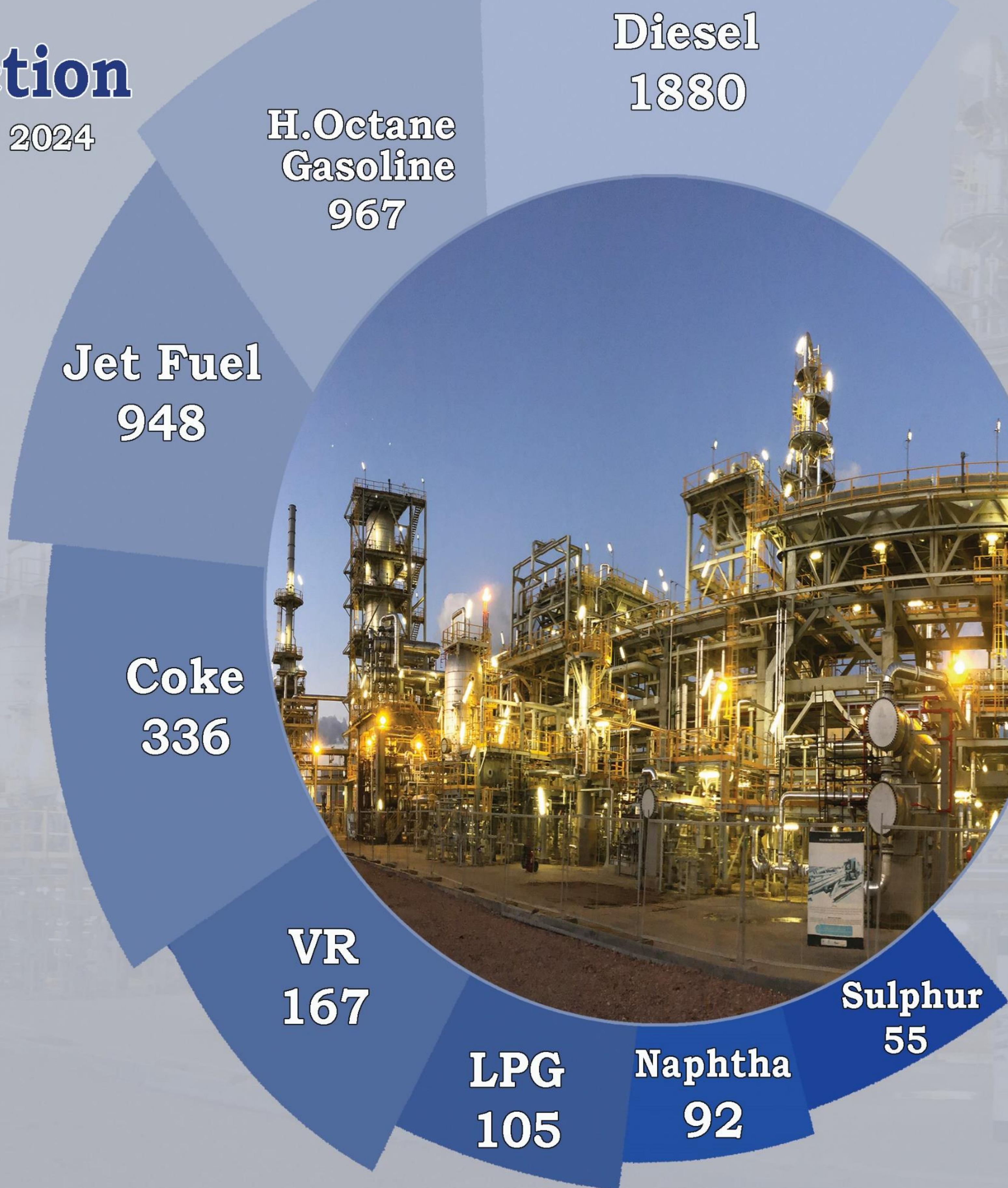

MIDOR Expansion Project

MIDOR expansions overall progress :



Expansion Project reached Provisional Acceptance by end of Sep. 2024.



A total of 95 million safe working hours have been implemented since the beginning of the project.



The periodic follow up reports of Self-Monitoring of HSES are ongoing and under review by Lenders consultant in accordance with the loan agreement.








During Sep.2024, all loan drawdowns was achieved, and MIDOR started to pay back the Loan instalments (5 instalments till Oct.2024).



MIDOR in cooperation with the project stakeholders completed the rehabilitation of the nearby clinic centers with its roles towards the refinery community.

In line with the Egyptian Petroleum Sector policy towards social improvement quality life and within the company's commitment to achieving sustainable development goals within Egypt's Vision 2030, MIDOR is currently contributing in some governmental projects upgrading in several activities as follows :

-  Contribute to the treatment of some cases for workers and their families in companies dealing with MIDOR directly.
-  Organizing HSE awareness campaign for orphans and youth with disabilities.
-  Distributing several school bags equipped with fundamental stationery and winter garments to surrounding schools near the refinery site in Alexandria.
-  The company supports the health sector, as it provides financial support to the Supreme Medical Council for workers in the petroleum sector and the Housing and Social Services Fund.
-  The company contributes effectively to supporting presidential initiatives, as the company contributed to the "Haya Karima" Foundation, by planning the reconstruction and equipping many houses.

Quantitative Risk Assessment (QRA) study for all refinery has been completed recently.

An initiative was launched to measure air pollutants and analyze groundwater well water inside the houses adjacent to the company in the western border. More than 50 houses were covered.
